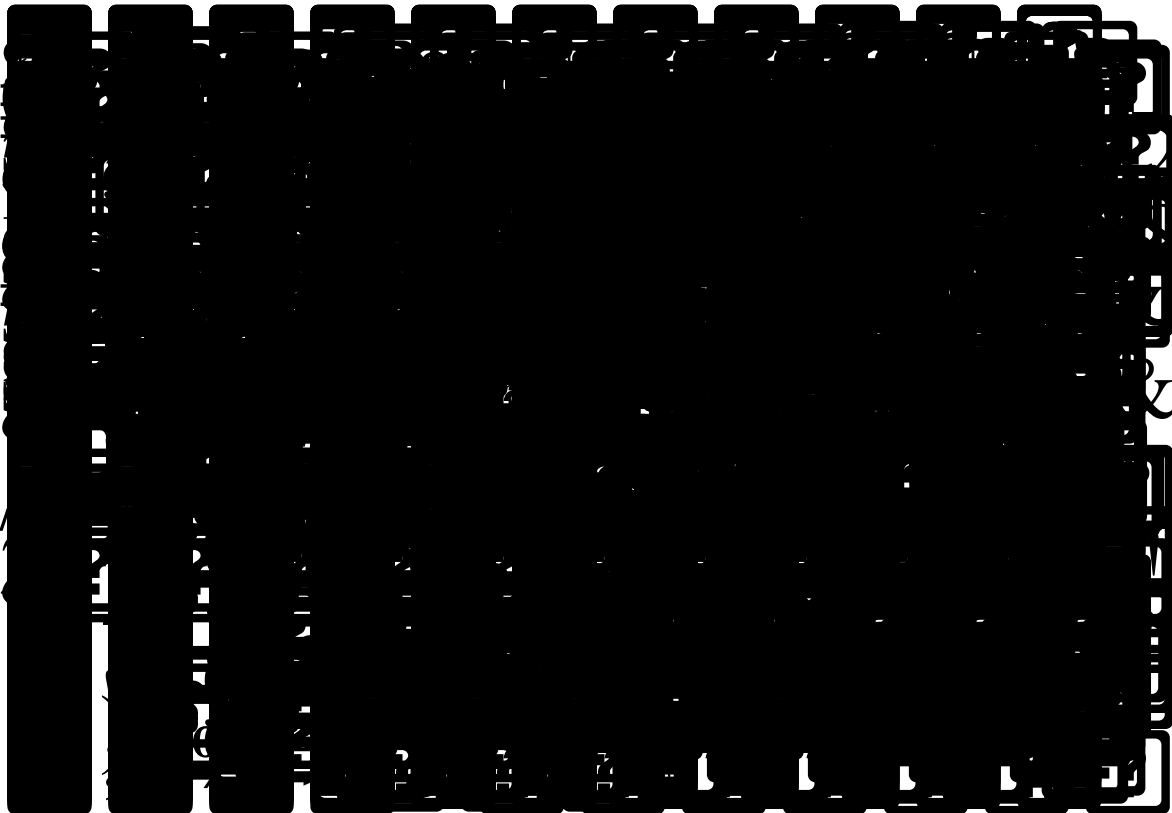
Also, please remember to pick up a current meeting list to have on hand after area each month.

The Public Relations subcommittee meeting was held this morning at Beyond Bread, Speedway & Wilmot, at 11:00 a.m. The meeting was attended by Gary M., Chairperson, Judy C., Dean W., and Sheryl W. The meeting was opened with the Serenity Prayer. There are currently nine bus shelters in Tucson and one in Nogales. The committee is still discussing the possibility of two interior posters for the bus. The cost would be \$500 annually (or \$20/poster/month) and the buses would run randomly throughout Tucson. The next PR event will be the Homeless Connect on Friday, February 17, 2017. The committee is looking for members who meet the current clean time requirement to join the SEAZNA-PR subcommittee.
