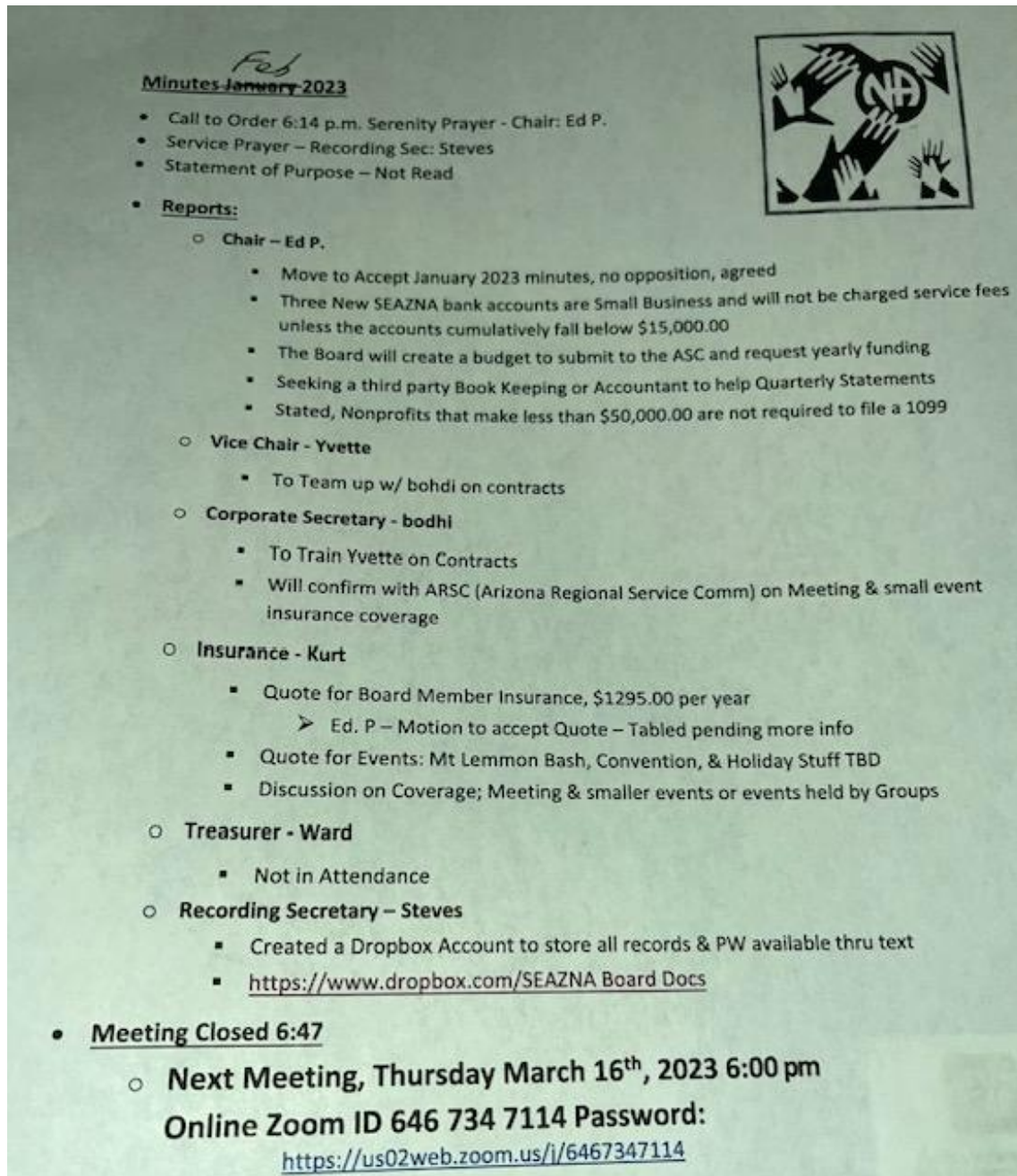

AGENDA: 1) Hotel sites for event—cost breakdown, amenities options

2) Discussion about using What's App instead of messaging

1) Steve presented a copy of his letter of inquiry and a spreadsheet showing five locations: LaQuinta, Doubletree, airport Sheraton, Desert Diamond, and Embassy Suites.

- Discussion followed, focusing on La Quinta, the least expensive at \$119 per night and a large mtg. room cost at \$3,000 (max capacity of only 120).

Bodhi suggested doing a boxed lunch, since food was not available; and Desiree added that having two meetings, one in Spanish and one in English, would be beneficial.

- Craig liked the Sheraton, citing the benefit of an airport shuttle. Desiree concurred, the primary reason being the airport shuttle. The Sheraton is the second least expensive, costing \$140 per night and a large mtg room at \$4,000. Because food is available there, Steve said selling food plates would knock down the meeting room cost. For example, 50 plates @ \$50 would slice \$2,500 off the \$4,000. Bodhi agreed on the Sheraton, because of the shuttle.

- Steve suggested the option to present the two options of La Quinta and the Sheraton and decide later, OR

- Steve asked if all agreed on the Sheraton, and all did.

- Future agenda items/ tasks would include:

1. Formalizing hotel contract, and getting it signed

2. Reaching out to local membership regarding programming

- 3. Open up pre-registration
  - 4. Decide on a theme, and have a logo contest
    - People should bring theme ideas to the next mtg. on April 4th
    - Bodhi asked that we have a table at the Alaska event in November for pre-registration and merch sales.
