We met on January 2nd, 2024. Topics of discussion included square website updates, merchandise, alternate logo contest, survey results, bank balance, programming, and events coordination.

10 groups participated in the 1st round of the atmosphere survey, and the committee wishes to send it out again in the hopes of receiving more input from the groups and the subcommittees. The WSLD Steering Committee did not meet for December but will resume meeting January 18th, 2024. This will be the final report from Alaska. We received 2 boxes of merchandise from Alaska and \$500 seed money. Reno, NV 2025 and it is looking like Monterey, CA 2026
